**Kingswood Primary School is committed to providing high quality programs and learning experiences for every child. Whilst the school receives funding from the Department of Education (DET) for the delivery of the standard curriculum, this funding only covers the cost of the basic curriculum program which does not include the extra programs and resources that Kingswood Primary School is known for.**

Without your continued financial support Kingswood Primary School may not be able to continue to offer the additional programs and resources that we are known for, such as, access to technology equipment, the Stephanie Alexander Kitchen Garden program, Japanese Day, the Performing Arts program along with the additional quality resources and additional education supports just to name a few.

### Payment Methods

Parents will be provided with notification of annual payment requests at the start of Term 4 each year. Reasonable notice will be given for any other payment requests during the year ie: excursions, incursions, camps and swimming.

Payment instalment options are available to all families at the school. You can choose to pay in 1 lump sum, 3 termly payments or 8 monthly payments. Please select the preferred option when processing payment through Compass.

# PARENT PAYMENTS POLICY

## ONE PAGE OVERVIEW



### FREE INSTRUCTION

- Schools provide students with free instruction and ensure students have free access to all items, activities and services that are used by the school to fulfil the standard curriculum requirements in Victorian Curriculum F-10, VCE and VCAL.
- Schools may invite parents to make a financial contribution to support the school.



### PARENT PAYMENT REQUESTS

Schools can request contributions from parents under three categories:

#### Curriculum Contributions

Voluntary financial contributions for curriculum items and activities which the school deems necessary for students to learn the Curriculum.

#### Other Contributions

Voluntary financial contributions for non-curriculum items and activities that relate to the school's functions and objectives.

#### Extra-Curricular Items and Activities

Items and activities that enhance or broaden the schooling experience of students and are above and beyond what the school provides for free to deliver the Curriculum. These are provided on a user-pays basis.

- Schools may also invite parents to supply or purchase educational items to use and own (e.g. textbooks, stationery, digital devices).



### FINANCIAL HELP FOR FAMILIES

- Schools put in place financial hardship arrangements to support families who cannot pay for items or activities so that their child doesn't miss out.
- Schools have a nominated parent payment contact person(s) that parents can have a confidential discussion with regarding financial hardship arrangements.



### SCHOOL PROCESSES

- Schools must obtain school council approval for their parent payment arrangements and publish all requests and communications for each year level on their school website for transparency.
